3. I will not operate nor permit anyone to operate my pit vehicle with any more passengers then allowed by the manufacture at any time. (i.e. no more than one person on a motorcycle; no more than 2 people on a 2 person golf cart/UTV; no more than 4 people on a 4 person golf cart/UTV)
4. I will not operate nor permit anyone to operate my pit vehicle in a negligent, reckless, careless or dangerous manner, and agree to indemnify and hold harmless Unlimited Sports MX, Inc., all lessees, lessors, American Motorcycle Association, their officers, agents and employees, sponsors, from any and all injuries and/or death, damage to personal and/or real property, and all financial loss resulting there from.
5. I will not operate nor permit anyone to operate my pit vehicle in excess of 10 MPH.
6. I will not operate nor permit anyone to operate my pit vehicle outside of the hours permitted. Pit vehicles are only permitted to be operated between the hours of 8 am and 6 pm.
7. I will not operate nor permit anyone to operate my pit vehicle on the State or County roads.
8. I will follow the standard rules of the road (i.e. Drive on the right side of the road, obey traffic rules, etc.)
9. I will not drive the pit vehicle into the track area or into the fenced spectating area.
